Replace the Floating Docks

Approximate cost: \$200,000

The floating docks are one of the major avenues connecting people to Oyster Bay here at The WaterFront Center. More than 20,000 people of all ages, backgrounds, and abilities (including disabled sailors), rely on these floating docks to provide easy and convenient access to the water, our fleet of sailboats, and our flagship, Christeen.

These docks are not only a platform from which we can provide education and recreation services, they also provide necessary storage to house our fleet of kayaks, paddleboards, and dinghy sailboats.



Replace Launch Boat

Approximate cost: \$90,000

Each season our Coast Guard inspected launch taxis people back and forth from boats to dock, logging more than 1,250 operating hours. A working, stable Launch is the vital link between the floating docks, our fleet of Sonars, and our flagship, Christeen. Without access to Sonars and Christeen, The WaterFront Center could not fulfill its mission in the same enriching and rewarding way we do today.
